Never empty your toilet waste and grey water in nature. Always use dedicated facilities in order to help improve our reputation as responsible campervan tourists.

### We all need to take care of nature

Please, only use dedicated facilities for disposal of waste water and toilet waste, and never empty the toilet waste into toilet bowls.

Disposal facilities and fresh water are available at most motorway service stations.

If the waste bin is full, please take your waste with you. Please do not place it next to the bin, just because others have done so.

Thank you for being a good role model and setting a good example.



## APPs and free camping

---

There are several websites and apps with overnight parking tips. Most of them are serious apps with legal and proper sites. However, some apps make it possible for everyone to register sites, which may seem good, but also legally or ethically questionable and such sites may result in conflicts between municipalities and property owners. Several municipalities are unhappy with campervan parking for the night on places that are inappropriate and where both the municipalities and property owners have not been consulted in terms of ethical parking.

So, please make sure to check the following when parking:

- 1. Are there any signs with restrictions or prohibitions?**
- 2. Are you alone on the site?**
- 3. How far away is the next residential building or other buildings, where some may have an opinion about you staying overnight? If in doubt, please make sure to ask for permission to stay for the night.**
- 4. How is the site located in terms of public paths, public areas and other places with people passing by?**

## Overnight stay

---

ACR's four types of sites, which usually have vacancies:

- 1. More than 100 ports and marinas with accessible facilities.**
- 2. More than 360 farm sites with up to three pitches and several of them with accessible facilities.**
- 3. More and more campsites offer designated campervan pitches inside and outside the campsite at good rates and conditions.**
- 4. More and more microbreweries and farm shops offer overnight stay against purchase of services.**

All four options above refer to parking only, meaning that all camping activities must be stopped at sundown - tables, chairs and awnings etc. must be packed away for the night.

If you want to stay overnight in another manner than the four options above, AutoCamperRådet recommends adhering to these simple rules:

- 1. Please do not disturb your surroundings and the view of local residents.**
- 2. Please do not park on private grounds without permission.**
- 3. Please do not park in places that may prevent local residents from entering their property.**
- 4. Please only park where it is legal and where there are no signs that prohibit campervans.**
- 5. Please avoid noisy behaviour while staying on site.**

## In short:

"Have I parked appropriately, or have I parked as it suits ME best?"

It is just a friendly reminder to start with ourselves and look inward in order for "US" to become better and change our behaviour.

Further, it will hopefully affect the inconsiderate people around us. Campervan tourists can gain goodwill by adhering to a set of ethical guidelines that basically are all about being considerate and not insisting on our rights.
